Ladies and gentlemen,

The South Asian Telecommunication Regulators' Council (SATRC) has been an important sub-regional programme of the APT for 17 years since its establishment in 1997.

It is a platform for regulators from nine South Asian Countries to discuss, network and cooperate on important telecommunications and ICT related issues in the South Asian region.

The South Asian region has seen rapid development of telecommunication network and services and the soaring consumer demand for broadband is well understood.

Broadband access, especially access using mobile devices, has increased and changed the regulatory and business scenario. However, limited resources in providing broadband communication have led to many constraints.

We have also heard of some of the pressing issues by the industry in the region. Some of these include unpredictability of licence renewal, equitable access to the scarce resources, taxation, and equal regulatory treatment for similar services and many others. During this meeting we will hear further regulatory issues and challenges as well as initiatives taken by the regulators to improve the telecom environment in the region.

With the wide deployment of broadband technologies and services, regulating the sector in any one country is no more feasible. Many of the recent issues for the regulators can only be solved through bi-lateral or multilateral cooperation.

It is important to learn the best practices and discuss and cooperate on policy and regulatory issues that are common to the region. For the South Asian countries, I believe SATRC is a good platform for sub-regional cooperation.
