PRFP is one of the annual high-level meetings held to address specific needs of the region in the area of policy and regulation. For over a decade, PRFP has grown from its humble inception to become a true platform for exchange of information, experiences, and viewpoints on issues of relevance to the Pacific.

The programme of PRFP for this year has been designed in line with the five Strategic Pillars of the Strategic Plan of the APT for 2018-2020 considering its relevance to the unique need of the Pacific.

The Singapore Statement provides strategic guidance and the pathways to the development of telecommunication/ICT in the Asia-Pacific region for the next five years. Next year, the new Strategic Plan of the APT for 2021-2023 will take the Singapore Statement as the guidelines of the plan.

I truly hope that the insights and information sharing from PRFP-12 will help resolve policy and regulation issues in your countries, be transformed into real practice, and finally contribute to the sustainable ICT development with safe and trusted environment in the Pacific as envisioned in the Singapore Statement. I humbly encourage your active participation to make the PRFP-12 a fruitful meeting. The APT Secretariat will remain at your disposal to do the needful should you have any request on the forum.
