Subject: Nomination of Candidates for the Position of the Chairman, Vice-Chairmen and other Office Bearers of the APT Conference Preparatory Group for WRC-23

Please refer to the APT's letter dated 29 July 2020 inviting your administration to nominate the representatives to attend the 1st Meeting of the APT Conference Preparatory Group for Work Radiocommunication Conference 2023 (APG23-1) which will be held virtually from 24 to 25 September 2020.

The main objective of the APG23-1 is to initiate the preparatory process of APT for the World Radiocommunication Conference 2023 (WRC-23) and Radiocommunication Assembly 2023 (RA-23) including to elect the Chairman and Vice-Chairmen of the APG-23, to form the structure of the APG-23, to appoint other Office Bearers of the APG-23 based on the structure, and to develop the work plan of the APG-23.

In this regard, I would like to invite your administration to submit official nomination of the candidates for the following positions:

- 1) Chairman of APG-23;
- 2) Vice-Chairmen of APG-23 (two positions);

Nomination of the candidate(s) shall be in an official letter signed by the high level official or APT focal point of your administration along with a detailed CV of the candidate describing his expertise in the relevant areas. It is advised to submit the official nomination on or before **3 September 2020** by email to aptapg@apt.int or fax +66 2 5737479.

I would like to emphasize that to ensure a successful regional preparation for WRC, it is important that the office bearers of APG-23 have excellent knowledge in the area of Radiocommunication and sufficient experiences on the preparatory process of WRCs and RAs. In addition, for the chairmen of various Working Parties of APG-23, it is vital that the candidates are experts on the agenda items related to the Working Parties.
